ORDER:

In the reference 1st read above, orders were issued that all the Government work contracts executed from 01-07-2017 to 21-08-2017 shall attract GST @ 18% with input tax credit and from 22-08-2017 @ 12% with input tax credit, & w.e.f. 13-10-2017 onwards the works contract involving predominantly earth work (i.e., constituting more than 75% of the value of the work) shall attract 5% GST with input tax credit.

- 2. The Government of India, vide the notifications in the reference 2nd & 4th read above, have issued certain amendments inter-alia revising the GST Rates on works contracts. The Revenue (CT) Department, Government of Andhra Pradesh have issued consequential orders vide the references 3rd & 5th read above for the implementation of enhanced GST rates in the State of Andhra Pradesh.
- 3. In the reference 6th read above, Finance Department has addressed the Nodal Department i.e., the Water Resources Department to prepare draft guidelines for implementation of the aforementioned notifications.

- 4. In the reference 7th read above, the Water Resources Department has furnished the minutes of meeting of the Board of Chief Engineers(BoCEs) held on 07-09-2022 along with their recommendations.
- 5. Government, after careful examination of proposal of the Water Resources Department, order for the implementation of the revised rates of GST as noted in the Table below.

- 6. The revised rates of GST mentioned in Column 4 of the Table in Para 5 above shall be applicable for the works measured and recorded on & after the date mentioned in Column 5 of the Table.
- 7. All the Drawing & Disbursing Officers & the Pay & Accounts Officers (Works) concerned shall ensure that there shall not be any excess payments to the agencies due to the said amendments.
- 8. The Director of Works Accounts shall take necessary action to ensure that orders issued is implemented without any deviation and issue instructions accordingly.
- 9. The CEO, APCFSS shall make necessary changes in the CFMS program.
