#### ORDER:

1. In the circumstances explained by the Chief Engineer, SRSP Stage-II & FFC, Warangal in his letter 2<sup>nd</sup> read above, Government after careful examination of the issue, the following Amendment is issued to Clausc 13 (ii) of Annexure-I of GO Ms. No. 94 I&CAD (PW-COD) department Dt.: 1-7-2003.

#### FOR:

"Tenders up to 15% less than the estimate may be accepted, but for tenders which are less by more than 15% of the estimate, a Bank Guarantee or Demand Draft for the difference between the tendered amount and 85% of the estimate value should be taken so that the renderer leaves the work midway and the department is forced to call for tenders for the work once again, the Bank Guarantee or Demand Draft shall be used to finance the re-tendered work".

### READ AS:

"Tenders up to 25% less than the estimate may be accepted, but for tenders which are less by more than 15% of the estimate, a Bank Guarantee or Demand Draft for the difference between the tendered amount and 85% of the estimate value should be taken so that the renderer leaves the work midway and the department is forced to call for tenders for the work once again, the Bank Guarantee or Demand Draft shall be used to finance the re-tendered work".

- 2. This Amendment shall be incorporated in all the tender documents, Agreements concluded with effect from the date of issue of this order.
- 3. This order issues with the concurrence of Finance (W&P) Department, vide their U.O. No. 330/F8(2)/04-I, Dt. 4-2-2004.
